We are Saved by Faith Alone

"In order that the subject might be made quite clear...we receive forgiveness of sins for Christ's sake through faith alone" and "...through faith alone we are justified." (Article IV, Justification in The Apology to the Augsburg Confession).

Ephesians 2:8-9 8 "For by grace you have been saved through faith. And this is not your own doing; it is the gift of God, 9 not a result of works, so that no one may boast."

What else, besides having faith, must we do to receive forgiveness of sins and to be justified? The obvious answer is nothing. That's what faith alone means. Could God have chosen to save us through the use of physical means like water in baptism? Yes, maybe. However, he didn't. He chose a different way. He chose to justify and save us by our faith alone. Yet, as Lutherans, we participate in practices we call the "Means of Grace." What do we mean by the Means of Grace? It is not a phrase found in the Bible. However, it is a phrase we Lutherans use to help explain a deep truth of God's grace.

"Baptism, the Lord's Supper, and Holy Absolution, along with God's Word as it is written, preached, and shared are sometimes called, 'the Means of Grace,' because through them, as through earthly elements, the triune God delivers His gifts of forgiveness of sin, life and salvation" (Luther's Small Catechism with Explanation, Means of Grace Question 292, emphasis added). Although God's Word by itself is a Mean's of Grace, "along with God's Word" means "connected with," not "independent of." Therefore, the earthly elements of baptism and the Lord's Supper are considered Means of Grace,

only when they are connected with and contain the pronouncement of God's Word.

This is because **Romans 10:17**, says, "17 Consequently, faith comes from hearing the message, and the message is heard through the word of Christ." Luther in the Small Catechism in answer to his question, "How can water do such great things?" states that, "It is not the water indeed that does them, but the word of God which is in and with the water, and faith, which trusts such word of God in the water. For without the word of God the water is simple water and no baptism." With respect to the Lord's Supper, the Explanation of the Small Catechism under Question 356 states, "Without Jesus' words, there would be no sacrament..."

The Augsburg Confession, Article XIII: Of the Use of the Sacraments, states: "Of the Use of the Sacraments they teach that the Sacraments were ordained, not only to be marks of profession among men, but rather to be signs and testimonies of the will of God toward us, instituted to awaken and confirm faith in those who use them. Wherefore we must so use the Sacraments that faith be added to believe the promises which are offered and set forth through the Sacraments."

They therefore condemn those who teach that the Sacraments justify by the outward act, and who do not teach that, in the use of the Sacraments, faith which believes that sins are forgiven, is required.

Could God have chosen to save us through the use of physical means like water in baptism? That is the wrong question. The proper question is, "How did God chose to save us?"

Ephesians 2:8-9 8 "For by grace you have been saved through faith. And this is not your own doing; it is the gift of God, 9 not a result of works, so that no one may boast."

No one should say, "Because my parents had me baptized as a baby, I am saved." Nor should anyone say, "My sins are forgiven because I took communion today." No one's actions other than Jesus', especially not our own, have the power to save us. Earthly elements do not have the power to save us. Instead, we declare that we receive forgiveness of sins for Christ's sake through faith in Jesus' death and resurrection, and through faith alone in Jesus Christ, we are justified. We participate in the **Means of Grace** in order to hear God's promises to forgive our sins and to grant us everlasting life as declared by the **Word of God** which is spoken during the sacraments. And through the hearing of that Word, we awaken and confirm our faith in Jesus Christ our Lord and Savior.

Council Actions: At the March meeting, the council reached consensus on the following: 1) Should pastor accept the call and moving assistance not be necessary, deplete the Pastor Relocation fund by applying it to salary; 2) investigate pricing and possibly apply for a tech upgrade grant for the sanctuary offered by the LCMS; 3) Nominating Committee is Phillip B, Deb F, and Julie R. A motion to purchase 2 laptops, one for the office secretary and one for the treasurer with a purchase limit of \$1500 passed. The property board will take care of the purchase.

The Nominating Committee is tasked with seeking candidates for the May election that will implement the new structure approved in the bylaws. The positions to be filled by election in May include: Vice President, Secretary, Financial Secretary, Head Elder and one additional elder. The bylaw update: 1) eliminated term limits; 2) moved the Property Chair to even year election and 3) replaced 5 boards with a Christian Ministry board elected in even years.

The description of the Christian Ministry board per the bylaws and the election cycle follow. As 2021 is an odd year, the Christian Ministry and Property board chairs will be appointments for one year until the normal election cycle begins. The Christian Ministry chair can be viewed as a coordinator position working with three other folks (or more) of their choice to provide guidance for the continuation of those activities which the congregation supports in the area of fellowship (inreach), missions (outreach) and stewardship (website and all resources).

There are no specific requirements for numbers of activities, meetings or agendas. Though five boards were eliminated, the folks active on those boards will be a great resource for the new board chair in supporting those activities that are dear to them, the church and the community.

Should you be approached by the nominating committee as a possible candidate for the Christian Ministry board chair, do not be fearful or timid. God does not call the equipped, He equips the called!



The Board of Christian Ministry

A. This board shall consist of the board chair and at least three (3) additional. Members shall be appointed by the board chair with the oversight of the church council.

B. This board shall have responsibility for nurturing activities for the membership, directing outreach missions and ministries, promoting engagement in stewardship, and communication of the same.

ARTICLE E: ELECTION OF OFFICERS

A. Officers of the congregation, board chairs and elders must be voting members. All terms of office shall be two years.

B. The office of president, treasurer, the board of Christian ministry chair, board of property chair and approximately half of the elders will be elected in the second quarter of even numbered years, taking office on July 1.


